Columbia River Salmon Budget Crosscut

The Office of Management and Budget (OMB) has prepared the Columbia River Salmon Budget Crosscut pursuant to the Memorandum of Understanding, dated December 14, 2023, entered between the United States and the Confederated Tribes and Bands of the Yakama Nation, the Confederated Tribes of the Umatilla Indian Reservation, the Confederated Tribes of the Warm Springs Reservation of Oregon, the Nez Perce Tribe, the State of Oregon, the State of Washington, and the National Wildlife Federation.

The purpose of this crosscut is to present information on Federal annual funding for programs and projects targeted toward restoration of salmon, steelhead, and other native fish populations in the Columbia River Basin. The Federal annual funding included in this crosscut is complemented by the Administration's restoration efforts funded by the Infrastructure Investment and Jobs Act (Public Law 117-58) and the Inflation Reduction Act (Public Law 117-169).

This Columbia River Salmon Budget Crosscut includes best available information on FY 2023 enacted, FY 2024 enacted, and FY 2025 Budget for the following agencies covered by the Presidential Memorandum:

- Department of Agriculture;
- Department of Commerce;
- Department of Energy;
- Department of the Interior;
- Corps of Engineers—Civil Works; and
- U.S. Environmental Protection Agency.
